THE PROMISES AND DILEMMAS OF INDONESIA

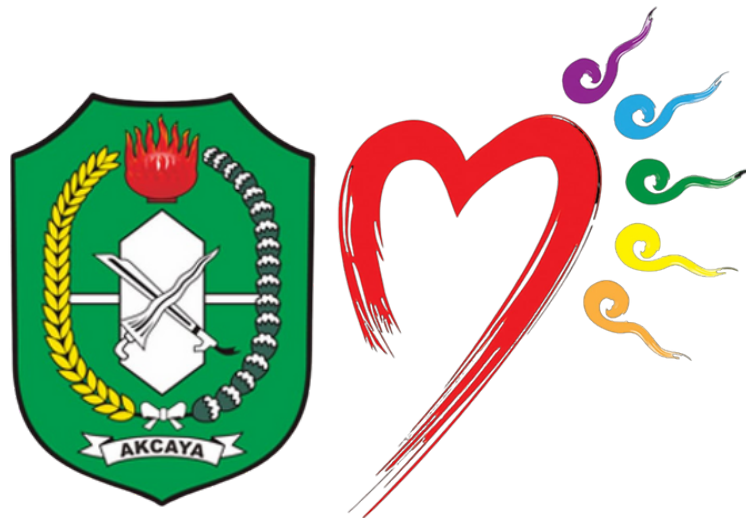
The American Institute for Indonesian Studies (AIFIS), in collaboration with Michigan State University (MSU) Asian Studies Center, will hold the 3rd annual AIFIS-MSU Conference on Indonesian Studies from July 11-15, 2023. The conference continues to highlight and celebrate the growing and evolving academic study of Indonesia, and aims to expand research dissemination and collaboration by connecting Indonesian scholars with international colleagues in a bilingual and virtual format.

This year's conference theme, "The Promises and Dilemmas of Indonesia," seeks to inspire reflection on Indonesia's successes, discontents, and efforts to rework, reinterpret, and negotiate all aspects of civic, legal, and cultural living, against and in light of Indonesia's internal fractures and frictions and its important profile and positionality globally and in the Asia-Pacific region. The conference seeks to explore and investigate a broad range of topics, including kebangsaan, in its diverse and competing meanings, adat and law, gender and race, environment and climate change, business, politics,, religion, and Indonesia's place in the world. Indonesia continues to grapple with internal tensions and regresses as she also reaps the rewards of developmental leaps and resilience amidst global uncertainties and adverse challenges from the impacts of the COVID-19 pandemic, shifting geopolitical relations, and economic volatility.

The Conference Program Committee selected a multidimensional theme for our conference, one which is at once capacious enough to welcome and allow for an array of scholars working in/on/from Indonesia to reflect the specificity of Indonesian Studies in our current global climate. We encourage scholars to present research and reflections on the ways scholars of Indonesia historicize the country's past, navigate current times, and explore imaginative futures and possibilities, all while contributing to the richness of the community's collective legal and ethical-epistemological frameworks.

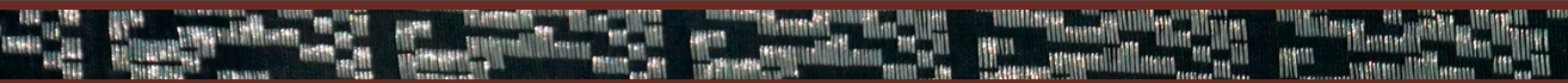

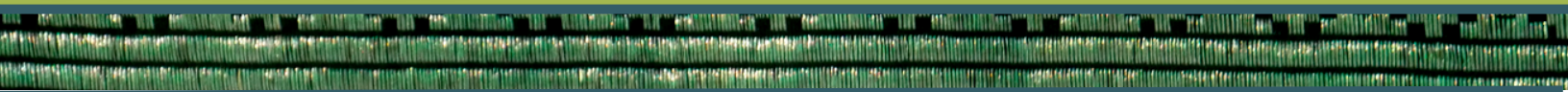

Researching the Promises and Dilemmas of Intellectual Property Law for Regional Arts

Indonesia's intellectual property (IP) development poses promises and dilemmas to its diverse regions. Debates over copyright laws, UNESCO heritage programs, and cultural property claims reveal the naturalization of exclusive ownership of regional arts. This challenges shared activities vital to community reciprocity and sustainable livelihoods. IP laws disrupt informal copying practices and cross-cultural contacts that have fueled the evolution and spread of regional arts. Additionally, the rise of "intellectual property consciousness" and "cultural theft" rivalries further complicate the landscape. As Indonesia navigates this territory, it seeks to balance the protection against foreign "cultural theft" while preserving regional affinity, creative autonomy, and political scale. Collaboration between Indonesian and foreign scholars is essential in recognizing interconnected histories, laws, arts, and scholarship.

Old, Broken, and New Promises: The Dilemmas of Kebangsaan in West Papua

This roundtable panel focuses on the dilemmas of Indonesian nationalism in relation to West Papuan lives and sovereignty. It examines the negative impacts of state projects, such as deprivation, land dispossession, deforestation, and environmental hazards in West Papua. The panel also explores the promises and practices of sovereignty by Papuans, including the potential for an independent West Papuan state and the resolution of Indonesian dilemmas. These practices encompass a "Green State" concept, peaceful coexistence between Papuans and migrants, a federal government of tribes, and improved conditions for women. The participants will discuss the evolving nature of these dilemmas and promises, as well as potential solutions.

Redefining the Non-Violent Masculinity: A Study of Youth-led Peace Preservation in Ambon

The conflict that took place in Ambon in 1999, subsequent to the fall of the New Order government, was resolved in 2002 with the signing of the Malino Agreement. Despite this, there are concerns about the potential for conflict arising from religious and ethnic tensions among members of the Ambonese community. In an effort to maintain a peaceful environment, various segments of society have initiated measures to promote peace. One such segment comprises the Ambonese youth who employ literature and the arts as tools for promoting peace-building activities in their daily lives. This presentation aims to investigate the dynamics of peace-building mechanisms in literature and the arts practiced by Ambonese youth in the post-conflict period. The study focuses on hegemonic masculinity as a concept that has been redefined in practice in certain communities. The presentation will highlight the shift from hegemonic masculinity associated with violent practices to non-violent hegemonic masculinity. Additionally, the presentation will provide examples of the dynamics of peace preservation efforts by Ambonese youth from the early post-conflict period to the present day, 20 years later.

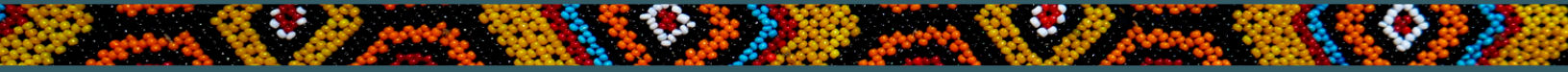

Law Reform and Global Positionality of Indonesia

Law reform has been a topic of discussion in Indonesia since the country gained independence. Efforts to replace colonial laws with national laws have not been easy to implement due to competing political and economic interests, yet the idea of reform is central to civil society and resistance throughout many periods of contemporary Indonesian history. While legal reform has remained on the national agenda for over 70 years, economic programs have often taken priority due to the country's history of colonization and domination by foreign corporations. A discourse paused for nearly 32 years during the period of repression under President Soeharto, the idea of legal reform resurfaced after his resignation in 1998, with Habibie's presidency launching a series of wide-ranging reforms, such as reinstating freedom of association, holding free and fair elections, and establishing new agencies like the Corruption Eradication Commission. Under Habibie's presidency, people began to see changes and a revived sense of hope that Indonesia was in the process of opening up a new chapter. Today with the enactment of a new penal code, Indonesia is in the midst of reviving a long standing debate on legal reform and officially marking a new chapter in the nation's legal frameworks. My work takes a historical look at law reform in Indonesia in order to highlight the challenges that the nation has faced in replacing colonial laws with new laws, and the implications this process has had within Indonesia's new legal system and global positionality moving forward.
